General Meeting Minutes for September 3, 2013

General Session: Called to order at 7:04 p.m. by Vice President Jesse Calleros. Officers in attendance included: General Director Henry Smith III, Treasurer Dennis Anderson, Photographer Rob Askegaard, and Secretary Ted Broberg. Also in attendance were "Taz" and Linda Elllyson, their daughter Danielle, Joni Whitsitt, Randy Wilbur, Ross Thomas, Jeff Greene, John Anderson, Alex Beller, Wil Downs, Bob Voss, Sid Hood, Roger Nahas, Brian Schoenly, and Mike Fox.

- A. Jesse showed his video: Jets Volume One, THUNDER -- ATTITUDE AND ALTITUDE.
- B. John Anderson spoke on his various model aviation classes:
 - 1. He has a 5-week program at Orange Coast College Aviation Program at Estancia High School.
 - 2. He is continuing with his Science, Technology, Engineering, and Math (STEM) programs.
 - 3. John wants a list of people who will help put together a youth education program: Contact John A. at: 989-723-1556.
 - 4. Concerning Archeology at Fairview Park: He works with two archeologists in his Youth Education program. They may work with us.
 - 5. John had some comments about the vernal ponds.
 - 6. He has several paper models: "FLYING PLANK," by Al Backstrum; Pie Plate Plane; Foam box plane.
 - 7. For Estancia High School: we'll need tools and materials, and places to store this stuff. See newsletter.
 - 8. He warns us that the City is considering NOISE ORDINANCES and NUISANCE ORDINANCES.
- C. Jesse announced the event: Oct. 26, DAWN PATROL, at Black Star field. World War I Golden Era RC flying,
- D. Joni: Oct 19: Show of Plastic miniature planes at Yank's Museum.
- E. Jesse showed some of his miniature indoor helicopters.
- F. HENRY SMITH III: Politics you need to know:
 - 1. Vernal Pools: One was damaged by the DG path, and it's causing a political crisis.
 - 2. Helicopters may be flown at the present location, but we have been asked not to post a map and set of rules until things are resolved. (He showed photos of some of the pools.) Editor's note: Since this meeting, helicopters have been banned from the designated area until further notice.
 - 3. Be very polite to anyone who comes near you. <u>BEST TO HOLD OFF FOR NOW: RANGER SAYS NO FLYING THERE.</u>
 - 4. John A.: A pool may be moved if it can be "mitigated" with additional replacement area.
 - 5. Suggestion: Consider a plan to reach the non-HSS club members who have City permits: arrange with the city to require a safety-training program before they can get their permit.
 - 6. He'd like us to start in December, on a Saturday, and Sunday, and a weekday, to do safety lessons, so fliers can get a qualification document to present to the Parks Department when applying for a permit to fly. A map of the field, with rules and areas for types of aircraft, would be included.
 - 7. "Don't argue with anybody in a uniform. If a ranger asks you to pack up and leave, do so."
 - 8. Henry passed around maps and photos showing the field, and our areas of concern.
- G. Taz: "I'm with the Freedom Committee, vets from World War 2 and up. We go to schools, and tell them about what we have done, or show picture and movies. Any of you guys who want to have a part in this, we'd love to have you. Community Center, in the Park; Wednesdays, noon. See Taz. " 60taz@att.net.H. Jesse: We need candidates for next year's officers. (See 2014 ballot elsewhere in this newsletter. Ed.)

Ted's efforts are part of what keeps HSS a Gold Leader Club.



Meet the Mayor

There have been a lot of city meetings and public involvement with the proposed changes to Fairview Park. While the survival of HSS and our flying field is part of it, the topic has exploded as a result of blunders by the city council. The following is the result reported by Ted Broberg of a public meeting held near the South West corner of Fairview Park, on September 12.

Hi, All,

I just got back from the house at the north end of Pacific Drive, where the Stricklands hosted a group of people who wanted to "Meet the Mayor." Must have been over 100 folks there. Mssrs. Righeimer, Muñoz, Mejia, Amburgey, Anna Vrska, Sandy Genis, Terri Fuqua, Kim Hendricks, and of course Dara and Jordan Strickland were the folks I recognized, plus John R.

Ernesto Muñoz spoke first, telling about the project's plans and their relationship to the Master Plan, and the funding needed. the Mayor spoke to the crowd, allowing individuals to speak. He interrupted several of them, but they each kept on subject. He put his foot in it when he said that parts of Pacific Drive were like a "third-world country." He apologized and back-tracked later, saying he meant just the K-bar (?) barrier at the north end of the street, and the lack of sidewalks, and some other unsightly yards were "like a third-world setting."

Citizens spoke to the issues of lack of sidewalks for children and moms with kids and strollers having to walk in the street, with speeding cars; cars using their driveways to turn around; no safe bike route, etc. Many wanted to know more about the need for, or size requirements of the proposed emergency vehicle turn-around space.

Two speakers commended Mr. Muñoz for his professional service.

At times the mood of the crowd became more vociferous, taking to task remarks made by the Mayor. His saying the homeowners are of the "Not in my back yard" persuasion was not well-received. "You are not listening to us!" was said often.

I left around 7:30. I do not know how long people stayed there.

This last link covers a lot of city blunders in a very humorous manner.

The following comments came from the "Meet the City" event of October 4, provided by Ted Broberg.

In attendance were Henry Smith III, Jim Sonnenmeier, Bob Voss, Jesse Calleros, Jim Hanson, Alex Beller, and Ted Broberg from HSS; Robert Staples and Bart Mejia from the City; plus their secretary, whose name I did not get.

- 1. The Fish and Wildlife Service indicated that they may want to chain off major areas-- including possibly our landing strip. Maps of these proposed areas will be handed out informally by one of our members.
- 2. Helicopters are presently not to use the area east of the paved walkway. We are to post signs there stating "Closed until further notice." [Ted will post them on both kiosks, at the container, and on one table at the heli site.]
- 3. Henry told the City staff that we have tried to get contact information for the non-HSS-members who have permits to fly, to keep them informed about what's happening, but have not been able to get that information as yet.
- 4. There will be a Native American / Tribal gathering at Fairview Park Saturday, October 5, to have a prayer time.
- 5. We are to inform Bart Mejia about anything we are doing (such as a Fun Fly or contest).
- 6. Robert Staples said that he is training two "Ambassadors," volunteer docents, with a golf cart. They will range over the entire park, to monitor and advise people using the park, including the Wetlands. Others who wish to serve in this capacity should contact Mr. Staples.
- 7. Question: Are the improvements going on? A. Bart Mejia answered, "The safety lights and fence at Canyon Drive will be put in; it was just decided. There will be a turn-around, but no lights."
- 8. The existing trails from Canyon Drive north will be reconstructed, paving with concrete, using a Federal grant.

HSS Meeting with Fairview Park Citizens Advisory Committee October 4, 2013

Attending HSS members included Henry Smith III, Jesse Calleros, John Rittenhouse, and Ted Broberg. After the pledge to the (missing) flag, the Mission Statement was read: To evaluate and determine the park needs, and make recommendations.

Presentations were made by G. Browley of the Costa Mesa United Sports Council of 14 youth organizations and Mr. Castignetti of the Orange County Model Engineers.

HSS Meeting with Fairview Park Citizens Advisory Committee October 4, 2013 (Continued)

Member Eckles gave numbers of sports fields, and the number of youth involved: 35 fields, some in Newport-Mesa; 90,000 youth annually. Eleven "utility" fields, six for baseball only. Fields shared with school district: 32 utility, 18 baseball. Some have no lights.

Citizens were invited to speak for up to two minutes on their concerns. Many wanted the park left without further development.

19 spoke in favor of keeping the park as it is. 13 asked for sports fields to be added. 3 spoke for the trains, and 3 Native Americans spoke up for preserving the site for its cultural and historic importance.

Some comments include these:

"I've heard campaigners call Fairview Park "The Crown Jewel of Costa Mesa." Don't change it."

"I run a program for young ladies dealing with obesity. We involve them in basketball. We have a hard time finding courts."

"Open your mind a little bit. Revise the Plan. Expand the playing facilities."

"I'll see you in court if you don't follow the Master Plan."

"Five percent of the park would make a nice field. A soccer field takes one acre."

"Admit it: This place WILL be developed, sooner or later. Let's do it right, and do it now."

"Get rid of some building, or a golf course."

"Tear down some of the problem motels and put fields there."

"How passive would the field be? How late would we hear the (referees') whistles?"

"Governor Brown has added a Tribal Council advisor to his staff. ... Many federal, state, and Tribal mandates must be followed. They have not been obeyed."

"The Great Park has opened four soccer fields, and plans on adding 20 more."

"Can you afford to build fields? You haven't paid for what you've already spent."

Early History of the HSS

Origin of the Harbor (Slope) Soaring Society. By Frank Colver 8/11/2013

In 1960 I saw a couple of guys slope soaring radio controlled model gliders on the east bluff of Newport's Back Bay. Since I was already a power model flyer I converted a free flight glider (Nordic 72) to single channel R/C and within a couple of weeks I was flying with them. It didn't take long for more glider flyers to join the group and I didn't fly powered planes anymore since I could fly much longer on slope lift.

As the group of flyers grew it also caught the attention of the land owner, the Irvine Co. Sometime around 1962 we were told that the only way we could be allowed to continue using their property would be to get an annual permit from the company. The big stumbling block to getting that permit was a requirement for third party liability insurance, naming the Irvine Co. The only way we could get the insurance was to form a club group and purchase the policy. The AMA did not have insurance available for chapters at that time.

Tim Tunnel, the guy I first saw flying that day, had a dance studio on 17th St in Costa Mesa next door to Spark's Hobby Shop. He got in touch with as many of the flyers as he could and asked us to meet at his studio to discuss forming a club to get insurance or we would lose our site. I attended that meeting and we formed the Harbor Slope Soaring Society that evening. I don't remember how many were there but it was probably somewhere between 10 and 20. We took membership numbers and I became member #7. Someone, maybe Tim, took on the job of buying insurance and getting the first annual permit from the Irvine Co. We continued to renew the permit every year and at some point became a chapter of the AMA when we could get insurance from them.

In those early days there was a large open field from the bluff to Jamboree Rd. When Corona Del Mar High School was built. It still left a lot of open field behind the bluff. The end of that site came when the community of East Bluff was developed. At that time the Irvine Co gave us permission to move to the south side of Big Canyon and we started flying a fantastic cliff we called "Instant Lift". It could be soared in all wind directions from due west to due south and the back side could be flown in Santa Ana Winds. This site still had a huge flat field extending to Jamboree Rd. We started also setting up launching devices like bungee and winches to thermal soar when the wind wasn't sufficient for slope soaring. We held our monthly meetings in the high school. This was during the early to the late sixties. During that time we also started holding serious competition events and two or three world records were set there (I held one of them).

From about 1963 on we would also fly the bluff at the Fairview field as a change of scenery and for variety of flying. There was no park there and the land belonged to the Sate of CA. The field was gigantic because Placentia Ave did not cross it, so Fairview State Hospital was the east edge of the open field (hence we called it the Fairview site) and the two schools were not built yet.

We also started using the Fairview field for thermal flying when we discovered how good it could be at times. After we lost the "Instant Lift" bluff to the Park Newport development we adopted Fairview as our only remaining regular flying site, Sometimes we would go to the Castaway's bluff when the wind was due south. When Estancia High School was built we used the big grassy field there for thermal flying until more facilities made that unusable. By this time most competitive flying was thermal flying and not slope soaring and the club had become a mostly thermal soaring group so we dropped the word "slope" from the club name (I still have some of our original club emblems with the slope word in the name). We also changed our monthly meeting place to Estancia High School.

The Fairview field has a long history of model airplane flying dating back at least to 1963 for the HSS and certainly by individuals before that.

Editor's note: Thanks to Frank Colver for this great HSS history update. If possible, it would be good to get the history on dedicating our field to Max Freed.

Partial Collapse of North Hangar at Tustin MCAS

TUSTIN, Calif. (KABC) – On Monday morning October 7, 2013, part of the roof of a hangar collapsed at a former military base in Tustin, damaging a \$35-million dirigible and causing it to leak helium.

There's a gaping hole in the roof of the former Marine Corps air base hangar, inside of which sits a damaged zeppelin. Monday morning, a portion of structure built during World War II collapsed without warning.

"So there were occupants inside when the partial roof collapsed. Those folks were evacuated without incident or injury," said Orange County Fire Authority Chief Kelly Zimmerman.

But debris did puncture the \$35-million aircraft, releasing helium into the air. Helium gas is not flammable but it can suffocate.

"Our concern was that in an enclosed environment anyone entering that without a breathing apparatus would be rendered unconscious in a short period of time," said Zimmerman.

Worldwide Aeros, which leases the hangar from the Navy, told Eyewitness News damage to the airship is repairable.

A company spokesperson says the zeppelin is under development to move large cargo for commercial and military uses.

According to Orange County Supervisor Todd Spitzer employees reported hearing creaking in the area a week prior to Monday's collapse.

"Apparently there had been some debris, maybe some pieces of wood they describe that had fallen from the ceiling, and they apparently reported that to the federal government," said Spitzer.

Spitzer says the county is set to buy the property from the federal government to develop a regional park on the site.

"There is real legal and liability issues about whether the county of Orange as part of the military conveyance process could afford to take this structure in light of the fact that we have a big hole inside the structure," said Spitzer.

The hangar has been red-tagged. A building inspector will examine the damages. (By Leticia Juarez of KABC)

<u>Editor's Note:</u> Orange County Parks Department was E-mailed about the Regional Park status. Their reply was that the hangar problem was "just a bump in the road". John Rittenhouse is getting word that the application for Historic Site was unanimously approved. We hope we still have something to put the plaque on. As yet, those concerned with the hangar project have not been notified.




